Pursuant to R.S.A. 508:19 "Equine professionals are not liable for damages resulting from the inherent risks of equine activities. Under New Hampshire Law, a participant in equine activities assumes the risk of any injury, harm, damage, or death and any legal responsibility that may occur to participant from the inherent risks associated with equine activities."

I agree in consideration for my participation in the Competition/Event which this Entry Blank is used to the following:
I agree that I choose to participate voluntarily in the Competition/Event with my horse as a rider, handler, longeur, lessee, owner, agent, coach, trainer, or as a parent or guardian of the junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition/Event involve inherent dangerous risks of accident, loss and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death. With this knowledge and as an inducement for the landowners and organizers to allow me to ride on the grounds of the Event, **I Agree** to release Save Your Ass Long Ears Rescue, Langwood Farm, Competition/Event, the landowners, farms and any and all of their agents, employees, organizers, officials, directors, members, volunteers or officers (hereafter "the foregoing") from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if Harm resulted, directly or indirectly, from negligence of the foregoing.
I agree to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the foregoing.

I agree to indemnify (that is, to pay any losses, damages, or costs incurred by me) the foregoing and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition/Event.

I have read the Rules about protective equipment, including USDF Article 318 and 1713, and I understand that I am entitled to wear protective equipment and acknowledge that I am required to do so while WARNED that no protective equipment can guard against all injuries.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf.

I agree that Save Your Ass Long Ears Rescue, Langwood Farm and Competition/Event as used above includes all of their officials, directors, employees, agents, personnel, volunteers and affiliated organizations.
